In consideration of being permitted to participate in any of the WEMS (Wisconsin Endurance Mountain Bike Series) mountain bike events including but not limited to "12 Hours at John Muir", "Metro Challenge", "12 Hours at Blue Mound", "12 Hours of the Northern Kettles", "Stump Farm 12", "Levis/Trow 100", "Blufflands Epic Enduro Race," "Thunderdown in the Underdown", "Twelve Hours of Pitch Black Single Track" (here in after referred to as the listed WEMS events), I, personally and on behalf of my heirs, personal representatives, successors and assigns, hereby release, waive, discharge and covenant not to sue all organizers, promoters, sponsors, participants, the promoting clubs, the officials, the volunteers, private land owners, and any involved municipalities or other public entities (and their respective agents and employees), and all other persons and associations connected with any of the listed WEMS events and all of their officers, directors agents, employees, predecessors, successors, sponsors, exhibitors, and assigns (here in after referred to as the released parties) for any and all injuries and damages and/or death caused by the negligence of the released parties. I also understand that I am required to wear a helmet.

I have read and I voluntarily sign this agreement and I understand that by signing it, I personally, and on behalf of my heirs, personal representatives, successors and assigns, am giving up all rights that I might otherwise have to make claims against the released parties for their negligence in causing injury or death sustained by me as a result of my participation in any of the listed WEMS events.
